SECTION 4. FIRST AID MEASURES

Eye Contact

Specific Hazards Arising from the Chemical

Flammable. Thermal decomposition can lead to release of irritating gases and vapors. Containers may explode when heated. Vapors may form explosive mixtures with air. Vapors may travel to source of ignition and flash back.

Handling
